Sir/Madam,

This is with reference to your online application No. EX-00638-1718 registered on 27.06.2016, on the above subject.

In this connection, I am directed to convey the sanction for extension of provisional affiliation of the school with the Board for its **Secondary School Examination** for a further period of **five years w.e.f. 01.04.2017 to 31.03.2022** subject to the fulfilment of the following conditions:-

1. The School is required to abide itself by the Examination/Affiliation-Bye-Laws of the Board.
2. **The School is required to apply on online for further extension of affiliation along with the requisite fee and other documents by 30th June of the preceding year in which the Provisional Affiliation expires as per Rule 15.11 of Affiliation Bye Laws.**
4. The school will follow the syllabus on the basis of curriculum prescribed by NCERT/CBSE and text books publishing by NCERT/CBSE for the Middle Classes. The school will follow syllabus and courses as per scheme of studies prescribed by the Board for Secondary/Sr. Secondary School Examination and changes made therein from time to time.
5. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt from time to time.
6. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under **from Pre-Primary to Class XII** :-

- (d) School running on bigger campus of more than 02 acres, the number of students shall be restricted as per the actual facilities in the school which shall be proportionate to the optimum number mentioned at (a), (b) and (c) above.
- (e) Schools running on less than 01 acre campus shall restrict number of students as follows:-

40. In case of established violation of the provisions contained in Affiliation/Examination Bye-laws of the Board, the school shall be liable for disaffiliation as per Rule No. 17 of Affiliation Bye-laws.
41. The school shall enter into an agreement with the Board detailing the terms and conditions for grant of affiliation, which will be binding on both the parties.
42. Special conditions to be complied within three months:-
 - a) The school is required to submit an affidavit, in original, duly sworn in before a First Class Magistrate to the effect that the school is not sponsoring the candidates for Board Examination of any other School/Branch which is not affiliated to the Board.
 - b) The school is required to furnish latest year Board's result of Secondary (Class-X).
 - c) The school is required to submit latest year Income & Expenditure Statement as per norms of the Board.
 - d) The school is required to furnish renewed Sanitary Conditions, Drinking Water and Fire Safety Certificates issued by the competent authorities.
