CBSE/Respective State /UT Govt from time to time.

- In case of established violation of the provisions contained in Affiliation/Examination By laws of the Board, the school shall be liable for disaffiliation as per Rule No. 17 of Affiliation Bye-laws.
- 41. The school shall enter into an agreement with the Board detailing the terms an conditions for grant of affiliation, which will be binding on both the parties.
- 42. Special conditions to be complied within three months:
 - a) The school is required to submit an affidavit, in original, duly swom in before a Fin Class Magistrate to the effect that the school is not sponsoring the candidates for Board Examination of any other School/Branch which is not affiliated to the Board.
 - b) The school is required to furnish latest year Board's result of Secondary (Class-X).
 - c) The school is required to submit latest year Income & Expenditure Statement as penorms of the Board.
 - d) The school is required to furnish renewed Sanitary Conditions, Drinking Water and Fir Safety Certificates issued by the competent authorities.
